DESCRIPTION OF PROPOSAL

APPLICATION TREE NO.	SPECIES	PROPOSED WORKS
1, 2, 3 & 4	4x Ash	T1, T2, T3 & T4. Ash trees with advanced Ash Dieback. Trees regularly shedding branches into neighbouring property to the rear, propose felling the trees and not replacing as replacement trees are already growing adjacent to the Ash trees.

DISCUSSION

The four ash trees are in the mature age class and show signs of Ash Dieback disease (https://www.forestresearch.gov.uk/tools-and-resources/fthr/pest-and-disease-resources/ash-dieback-hymenoscyphus-fraxineus/). We expect these four trees will last for less than 10 years.

The trees overhang the neighbouring property and branch, or trunk failure could cause damage or harm.

From the Cumberland website, Tree Preservation Order TPO 13 (1952) protects these trees.

Our TEMPO assessment (page 2) shows a TPO is indefensible due to the poor health and reduced life expectancy of these trees.

RECOMMENDATIONS

Inform the applicant they can carry out the work in the application.
