T1	1x Cherry	Felling of a Cherry tree situated within a Conservation Area.	'T1, Cherry. Tree infected with Ganoderma Applanatum, has partially uprooted and come to rest against and is supported by the neighbours shed. The surface roots are visibly decayed. Propose felling the tree.'

DISCUSSION

The Cherry tree is in the mature age class, with a wood decay fungi (*Ganoderma* sp) at the base. The tree is growing close to the property boundary and appears to have partially failed at the root plate. As the tree continues to grow and possibly fail further, we expect it will cause damage the neighbour's shed and fence.

From the Cumberland website, the site is within the Whitehaven Corkickle Conservation Area.

We consider the work detailed in the application reasonable to prevent the tree failing and causing damage.

Our TEMPO assessment (page 2) shows a TPO is indefensible.

RECOMMENDATIONS

Inform the applicant they can carry out the work in the application.
