#### **DISCUSSION**

The Goat Willow tree is in the mature age class and growing close to the property boundary. The wide-spreading crown overhangs the property and the neighbour's property.

From the Cumberland website, the site is within the Whitehaven Corkickle Conservation Area.

We consider the work detailed in the application reasonable to prevent the tree from becoming a nuisance.

Our TEMPO assessment (page 2) shows the tree does not merit a TPO.
