The trees are in the mature age class and growing near the woodland boundaries.

From the Cumberland website, the site is within the Whitehaven Town Centre Conservation Area.

We consider the work detailed in the application reasonable to prevent the trees from becoming a nuisance.

Our TEMPO assessment (page 3) shows a TPO is indefensible for these four trees.
