Planning Branch Ltd has been commissioned to produce this report in support of the proposed development at Stephney Farm, Calderbridge. The proposal is for the creation of a hardcore agricultural track as part of a grant funded scheme. The proposal is part retrospective.

Map & Description of site




Stephney Farm is a livestock farm located outside of Calderbridge and Beckermet. There are a number of livestock tracks around the farmstead which allow livestock and farm vehicles to move around the farmstead avoiding poaching to the land which leads to pollution.


The site is located in flood zone 1. As the track is hardcore it will natural drain into the surrounding fields.

# **Rights of Ways**



The site is adjacent to the public footpath as indicated above. The site of the improved route is not located on the public footpath.

# **Heritage Asset**



The site is located outside of the World Heritage Site (LDNPA) and the nearest listed buildings are located in Calderbridge. Due to the distance from the heritage assets and the intervening fields the proposal would not impact on the heritage assets.

#### Woodlands

There are no woodlands that are close to this existing track that is to be resurfaced.

#### **PROPOSAL**

The proposal is for the hardcore surfacing of the existing partially hardcore track as part of a wider grant scheme to reduce poaching and pollution within the wider area. This part of the track has had hardcore laid to avoid poaching.

#### Amount

The track the subject is 185m long and 2.4m wide, resulting in 444m2 of area.

The proposal for the resurfacing of the existing previously created track would match other tracks on the farmstead.
