Discharge of condition 12 of planning application 4/22/2332/0F1; land to the west of Valley View Road, Whitehaven

Thank you for your notification of 17 July 2024 seeking the views of the Coal Authority on the above.

The Coal Authority is a non-departmental public body sponsored by the Department for Energy Security and Net Zero. As a statutory consultee, the Coal Authority has a duty to respond to planning applications and development plans in order to protect the public and the environment in mining areas.

The Coal Authority response:

Condition 12 of the permission states:

Prior to the occupation of the first dwelling hereby approved a signed statement or declaration prepared by a suitably competent person confirming that the site is, or has been made, safe and stable for the approved development shall be submitted to and approved in writing by the local planning authority. This document shall confirm the methods and findings of the intrusive site

investigations and the completion of any remedial works and/or mitigation necessary to address the risks **posed by the recorded mine entry**.'

We note that Condition 5 also seeks to address coal mining legacy issues, specifically applicable to both shallow coal mine workings and the mine entry. However, you will note, presumably by error, that Condition 12 only specifies the mine entry.

Notwithstanding the above, and **whilst we would have no objections to the LPA discharging Condition 12**, specifically as the Verification Report for the Treatment of Mineshaft (March 2024) confirm the stabilisation of the shaft, we look forward to receiving for consultation on the relevant information to address Condition 5.
