# Discharge of condition 3 of planning approval 4/24/2085/0B1; land to the west of Valley View Road, Whitehaven

Thank you for your notification of 30 August 2024 seeking the views of the Coal Authority on the above.

The Coal Authority is a non-departmental public body sponsored by the Department for Energy Security and Net Zero. As a statutory consultee, the Coal Authority has a duty to respond to planning applications and development plans in order to protect the public and the environment in mining areas.

#### The Coal Authority response:

Condition 3 of the planning permission states:

'No development shall commence until any remediation works and/or mitigation measures to address the mine entry and shallow coal mining works, as may be necessary, have been implemented on site in full in order to the ensure that the site is safe and stable for the development proposed.

The intrusive site investigations and remedial works shall be carried out in accordance with authoritative UK guidance.'

You will note the letter (dated 7 August 2024) from ID GeoEnvironmental Ltd, which accompanied 4/24/2240/DOC and which confirmed that all aspects of built development are outside the zone of influence of the shallow coalmine workings. The information allowed us to recommend the discharge of Condition 12 of 4/22/2332/0F1. Consequently, and on the basis that the Verification Report for the Treatment of Mineshaft 271515-008, which accompanies this application confirms the completion of the necessary treatment, the Planning and Development Team at **the Coal Authority is able to recommend the discharge of Condition 3.**
