#### Bats & Birds: Robertson memorials, Low Road, Whitehaven

Further to our conversation on Thursday 25<sup>th</sup> May, please find the results of both the preliminary assessment and bat activity survey of the Garage at Low Road, Whitehaven.

#### Introduction

Robertson Memorials, Whitehaven, propose to demolish an existing garage structure which abuts the office at Low Road, Whitehaven. The proposals are currently going through planning (ref:TA/2023/296) and the requirement for bat and bird surveys have been highlighted prior to approvals.

S.A.P Ecology & Environmental ltd were contacted and commissioned to complete a preliminary building assessment and subsequent bat activity survey of the garage.


The preliminary assessment was completed by Mrs Sarah Parkin BSc (Hons), ACIEEM, NE Bat survey licence 2015-11580-CLS-CLS on 25<sup>th</sup> May 2023. The assessment was undertaken during the daytime hours and comprised both an internal and external building inspection where direct evidence of bat and bird occupation was recorded. All areas of the structure could be seen and accessed.

The activity survey was completed by competent bat surveyor Mrs Lesley Grey on 29<sup>th</sup> May 2023. A vantage point was chosen during the daytime assessment which ensured to cover all access/egress features suitable for bats. In line with BCT good practice guidelines (Colins, 2016) the survey commenced 15 minutes prior to dusk and continued for 90 minutes after sunset. Any visual emergence/return was recorded along with any notable activity.

All surveys were carried out in line with good practice guidelines and there were no survey limitations recorded.

#### Results – Preliminary Assessment

The garage is a single story 'lean-to' style building of brick and wooden support beam construction (plate 1). A steel lintel is present above the door and a length of boarded up 16 pane windows present on the eastern aspect. The roof consisted of corrugated roof panels on top of wooden lintels and external roof trim on both the northern and southern ends.

Upon close inspection no bat droppings could be found within the property. Externally all areas were tightly sealed with the exception of the eastern aspect above the guttering where the corrugated roofing provided gaps to the internal wooden lintel beam within. This feature, along with the garage's location within the surrounding environment afforded the building a low suitability for roosting bats.

No bird nests or evidence of historic nesting was present.

#### Results - Activity Survey

Table 1: Summary of survey conditions.

Dusk	29/05/2023	21:33	10	10	There was no wind, 15% clear skies.

Weather conditions were good and viable throughout the survey. Multiple bat passes were recorded during the survey for both the Noctule Bat (*Nyctalus noctule*) and Common Pipistrelle (*Pipistrellus pipistrellus*). No roosts were identified within the garage.

#### Discussion

The preliminary roost assessment recorded a low suitability for roosting bats, and as such a subsequent emergence survey was carried out. The results of this survey confirmed that no bats are currently roosting within the garage structure or within a 5m radius. As no bat roosts are present the current proposals of demolition will not lead to a negative impact on any bats or their roosts. The proposals will also not have any effect on the surrounding foraging habitat.

At the time of writing S.A.P Ecology & Environmental can confirm that there are currently no recorded ecological constraints relating to bats or birds present within the garage highlighted for demolition.

Brick up existing window


Remove/recycle roof sheets and timber frame

Reduce/remove walls by hand and mini digger will load rubble onto trailer.


Dust suppression to be used as necessary.

Site will be left clear to existing concrete floor.


Remaining office wall will be plaster coated rendered with new guttering and down spouts fitted Installation of water pipe to be added.
