Sarah,

In response to the queries raised, I have attached an Addendum to the submitted LVA and an updated Planning, Design and Access Statement that addresses the likely impact of the proposal on biodiversity.

For reference, I have also attached a copy of a recent decision notice granting permission for a wind turbine with a tip height of 24.9m elsewhere in the district.

I would also like to reiterate that the proposal is for two micro-turbines with a hub height of 15m and a maximum tip height of 17.8m. The proposal is not for a commercial wind farm. By way of comparison, the Collins Tree Guide indicates that an English Oak can grow to 38m, a Sycamore to 38m, a Common Beech to 40m, a Horse Chestnut to 39m, and a Lime tree to 42m.

I hope this clarifies matters but if there are any further queries, please do not hesitate to get in touch.
