Whilst I do not agree fundamentally with the proposed outfall I believe that the drainage hierarchy has been considered, United Utilities have agreed in principle the discharge into the combined system at a forward pass rate not to exceed 5L/s for any storm event, with that in mind the proposed outfall to the combined system meets the criteria and the LLFA would welcome the opportunity to view further proposed drainage designs to that effect.
