I hereby give notice, in accordance with paragraph A.3(1) of Part 16 of Schedule 2 to the Town and Country Planning (General Permitted Development) (England) Order 2015, as amended, that Anglian Water Services Limited (Lancaster House, Lancaster Way, Ermine Business Park, Huntingdon, Cambridgeshire PE29 6XU) will be applying to Cumberland Council for a determination as to whether the prior approval of the authority will be required for the siting and appearance of the following permitted development:

“Erection of 12m slim line monopole to support 1no. Antenna together with earthworks, cabinet and associated development thereto.”

The application will be made to: Cumberland Council, Cumbria House, Carlisle CA1 2DE. The local planning authority has 56 days from the date it receives the application to consider whether prior approval will be required for the siting and appearance of the development proposed and, if so, to grant or refuse such approval and to communicate its decision to the applicant. The application will be made available for public inspection at the offices of the local planning authority during usual office hours.

Any person who wishes to make representations about the siting and appearance of the proposed development may do so in writing to the local planning authority at the above address. A period of at least 14 days, from the date of this notice, will be allowed for any such representations to be received by the Local Planning Authority.
