- The land has the benefit of the following rights granted by a Assignment thereof dated 15 April 1965 made between (1) Benjamin Douglas Plummer Arthur Norman Dudding Horace Wills Mawson and Ronald Farquharson (Vendors) and (2) Anthony Johnson and Mary Johnson (Purchasers):-

"TOGETHER with a right of way for the purchasers and their successors in title the owners or occupiers for the time being of the property first and secondly above described and all persons authorised by them to pass and repass over and along the roadway coloured green on the said plan at all times of the day and night with or without horses carts and motor vehicles."

NOTE: The roadway coloured green referred to leads from the south-western most boundary of the land in this title to Beach Road.

- 3 The Assignment dated 15 April 1965 referred to above contains the following provision:-
  - "IT IS HEREBY AGREED AND DECLARED bteween the parties that:
  - (a) the walls pillars and fences separating the said property from the adjoining property of the vendors shall be party walls and fences in accordance with section 38 of the Law of Property Act 1925 to be maintained and repaired at the joint expense of the vendors and the purchasers and
  - (b) the chimney stacks gutters spouts drains and other things hitherto used by the vendors as owners of the said property and of the said

adjoining property shall be party structures to be maintained and repaired at the joint expense of the vendors and the purchasers."  $\,$
