Proposed areas of demolition are isolated to outrigger extensions that are not inkeeping with the architectural style or setting of the conservation area and detract from the appeal of the former bank building.
Single Storey extension demolition to improve access to rear garden and provide improved entrances to side of property.
Double Storey extension demolition to rear of property, as this no longer a functional part of proposed building uses. Demolition will enhance external areas and provide additional external amenity space.

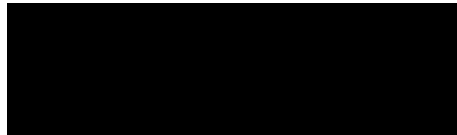
