#### **INSPECTION LOG**

When the following stages are reached, the work should pause to give the Council time to make an inspection:

- 1. Commencement of work
- 2. Excavations
- 3. Ground floor preparation
- 4. DPC
- 5. Radon protection measures
- 6. Drainage laid prior to coverage
- 7. Beams in place prior to covering
- 8. Roof timbers
- 9. Insulation to walls and roofs.
- 10. Completion

IMPORTANT – <u>This inspection log should be kept on site at all times and given to the builder</u> or person responsible for informing building control that the particular stage of work has been reached.

If the local authority is not informed of relevant stages of work for inspection, it may require the work to be opened up for inspection so that it can be ascertained whether or not the work complies with the Building Regulations.

Same day inspections may be possible if requested before 10.00am.

The Council reserves the right to carry out inspections at any point, in order to ascertain compliance with the applicable Building Regulations currently in force.
