## PLANTING SCHEDULE $\downarrow$

#### WILDFLOWER PLANTING:

All open areas that are in heavy shade will be planted with a mixture to establish wildflowers in areas of heavy or dense shade. Species in this mix are frequently found in wooded areas, alongside woodland edges and where shade may be heavy or prolonged.

#### These areas will be planted with:

Agrimony, Angelica, Avens, Bedstraw, Bellflower, Betony, Bluebell, Buttercup, Campion, Clary, Columbine, Foxglove, Hedge Parsley, Meadowsweet, Mustard, Ragged Robin, Sage, St John's-wort, Teasel, Vetch, Vetch, Wild Garlic / Ramsons, Woundwort, Yarrow.

#### All open areas not in shade will be planted with traditional wildflowers that are easily established and contains species frequently found in a diverse range of soil types and habitats.

These areas will be planted with:

Bedstraw, Black Medick, Burnet, Buttercup, Campion, Campion, Carrot, Catchfly, Clary, Cowslip, Daisy, Forget-me-not, Foxglove, Goat's-beard, Knapweed Common, Knapweed Greater, Musk Mallow, Self-heal, Sorrel, St John's-wort, Yarrow, Yellow Rattle.

#### **HEDGEROWS**:

All existing hedgerows will be rejuvenated, where hedgerow is missing or damaged/dead we will be replacing with a mixture of the following:

Hawthorn, Blackthorn, Field Maple, Alder, Wild Privet, Wild Cherry, Bird Cherry, Guelder Rose, Spindle, Juneberry.

Hedgerow boarders internal and external will be planted with UK native Cornfield Annuals wildflower containing: Corn Chamomile, Corn Cockle, Cornflower, Marigold Corn, Common Poppy.

The 850 new hedgerow that has already been planted is a mixed native RSPB approved bird friendly hedging specifically chosen for their value to birds, insects and other small animals, and consists of Hawthorn, Blackthorn, Guelder Rose, Alder and Field Maple. In addition to these I am due to receive another 150 hedgerow plants this week which will be used to fill any remaining gaps in the existing hedgerows. (All can be evidenced with receipts should they be required. All of the above are from the RHS "Perfect For Pollinators" list and are beneficial in creating a long lasting meadow and wildlife habitat.

### WOODLAND:

Where trees are no longer safe and where trees have historically been felled, we will be replanting with: 3-7 years old and consist of saplings consisting of 22 in total planted randomly as per plan, these consist of: 1 apple, 4 sweet chestnut, 3 horse chestnut, 4 walnut, 2 oak, 1 ash, 1 hazelnut, 1 field maple, 4 Scot pines and 1 wild cherry these will be planted between the cabins to maintain woodland.

## MAINTENANCE OF PLANTING $\downarrow$


PLANTING ESTABLISHMENT MAINTENANCE. INITIAL PLANTING.

- All planting of saplings will initially be staked and tied with expandable tie straps.
- saplings to be protected by 'spiral tube' tree guards. • inspected weekly to check support and protection remains intact, change out any broken or damaged elements.
- ensure ground is hydrated, water where ground observed to be dry.
- remove any excess grass / weed growth from within tube.

## ESTABLISHMENT PERIOD (up to 6 months)

- inspect fortnightly to check support and protection remains intact, change out any broken or damaged elements. • ensure ground is hydrated, water where ground observed to be dry. inspect more frequently in dry periods.
- remove any excess grass / weed growth from within tube.
- replace any saplings that are in poor health or have died away.

- MID TERM (after 6 months)
- inspect at least every 4 weeks to check support and protection remains intact, change out any broken or damaged elements.
- ensure ground is hydrated, water where ground observed to be dry. inspect more frequently in dry periods. • remove any excess grass / weed growth from within tube.
- replace any saplings that are in poor health or have died away.
- LONG TERMS (after 18 months)



• continue weekly inspections to detect any damage to saplings.
