### 3. Description of the Proposal

Please describe the proposed development, including any change of use:

United Utilities are currently undertaking a major infrastructure project known as the West Cumbria Water Supply Project. A significant amount of land belonging to Frizington Hall Farm is affected by the scheme, with over a mile of pipe being installed. As part of the construction process UU required a series of temporary double access gates (with hard standing and concrete aprons) along the route to allow machinery to access the pipelack. On MR Fearons land, 4 such access points were required. To that end, UU received planning approval for the access points, but the approval was given on the basis they would be removed at the end of the project. This proposal seeks to retain 3 of the 4 access points including the gates, hard-standing and concrete aprons on Mr Fearons land on a permanent basis once the UU project is completed. The retention of these access points will improve access to and from the land in terms of highway safety or visibility will be improved along the narrow single track road which is well used. In addition farm machinery can stay fully off the highway whilst field gates are being opened/closed.


