Variation of condition application to planning permission 4/22/2332/0F1, Land to the West of Valley View Road, Whitehaven.

Further to our recent email communication, Story Homes hereby submits revised details for the abovenamed planning application.

Garage amendments.

We are seeking to amend the current approved garages on the Wexford plots (plots 68,69,88) to align with our new standard A20 garages (see drawing reference Garage Booklet (A20) Single Garage 1 Planning drawing 1/1 drawing number GB-PLP1/1).

Amendment to swale details

This Section 73 application seeks to make changes to the swale and pond. These changes have been made following tech approval from United Utilities, due to their internal policy changes they now must adopt the full drainage system rather than just the pipe system.

The amendments seek to bolster the drainage system's ability to control erosion. The swale has been widened and slopes increased, further gabion baskets have been added to slow the water to an acceptable rate as it comes down the hill, concrete pitching has been added to protect the swale from erosion, a spill way has been formed at the bottom of the swale/entrance to the pond to protect the entrance to the pond, the pond has been slightly reshaped to ensure we don't have washout at its 'edges', the pond is now more curved. Drainage to the south remains unchanged.
