Hello, Paul,

First of all, my apologies for the delay in getting back to you regarding the conifer tree next to 12 Clitheroe Drive. It has been unusually busy recently and I wanted to see the tree first, which I have now done.

I'm in agreement with you, pruning the conifer tree would result in a most of it being removed as so much of it is overhanging the boundary and close to the property, so it would be better felled completely. In addition, this is a non-native conifer (quite probably planted) and as such not a tree we would wish to see in this area of Ancient Semi-Natural Woodland. I am therefore able to give consent and support your application to fell it, in a Conservation Area.

Once you have permission, can you please let me know?

And assuming you will need to carry out the work from Woodland Trust land, before I can give permission for that I'll need to have proof of your Public Liability Insurance for

£5 million, and also the relevant chainsaw certificates. As the tree is on Woodland Trust land I would then be happy for it to be stacked safely within the wood, or alternatively you may wish to chip and remove it.

Hello Rachel,

I have been contacted by Mrs Hetherington from 12 Clitheroe Drive, Whitehaven regarding a conifer overhanging her property from Crow Park Wood. I have attached the email from yourself granting permission to cut back the overhanging branches. Unfortunately the tree lies within a conservation area so planning permission would be required from the local authority, in this case Cumberland Council. As cutting back the overhanging branches would leave just a dead stem permission is unlikely to be granted so I would ask if I could meet the Estate Manager or their representative on site to discuss a reasonable scope of work or alternatively permission to remove the tree entirely. I have also attached a photograph of the tree to show its position in relation to the buildings and boundary.
