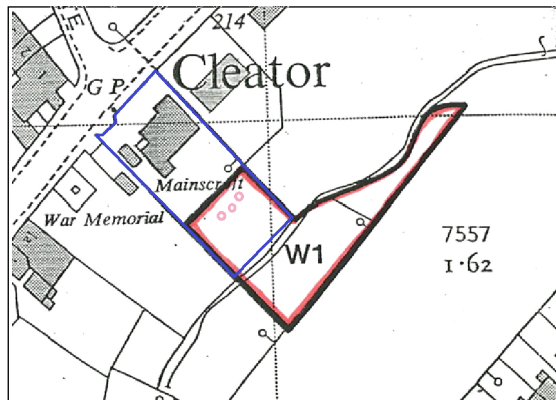

We have had a previous planning application for a 30 % crown reduction and dead wood on 3 trees that are covered under a TPO on our property. this permission was granted under 4/22/2176/TPO.  
These works have not been completed due to other time pressures. We are now ready to do the work but it is clear that the trees have Ash Die Back as they are shedding lots of new growth when they shouldn't be (see attached photos). Our tree surgeon has now indicated that we should look to 'pollard' the trees to a reasonable height as they have a better chance of surviving if we do this. This is backed up by the previous report by the Council Consultant Arboriculturalist which states that the TPO is indefensible. We do want the trees and the woodland as the land is not useable for anything but a wood/wildflowers. Note: since the previous application we have removed/recycled ~4 tonne sacks of waste (bottles, windows, lawnmowers, general plastic rubbish) from the wood, killed the ivy and situated natural earth bank paths to make access possible to maintain it for wildlife - hedgehogs mainly - and would use some of the wood from the trees to continue these efforts.
