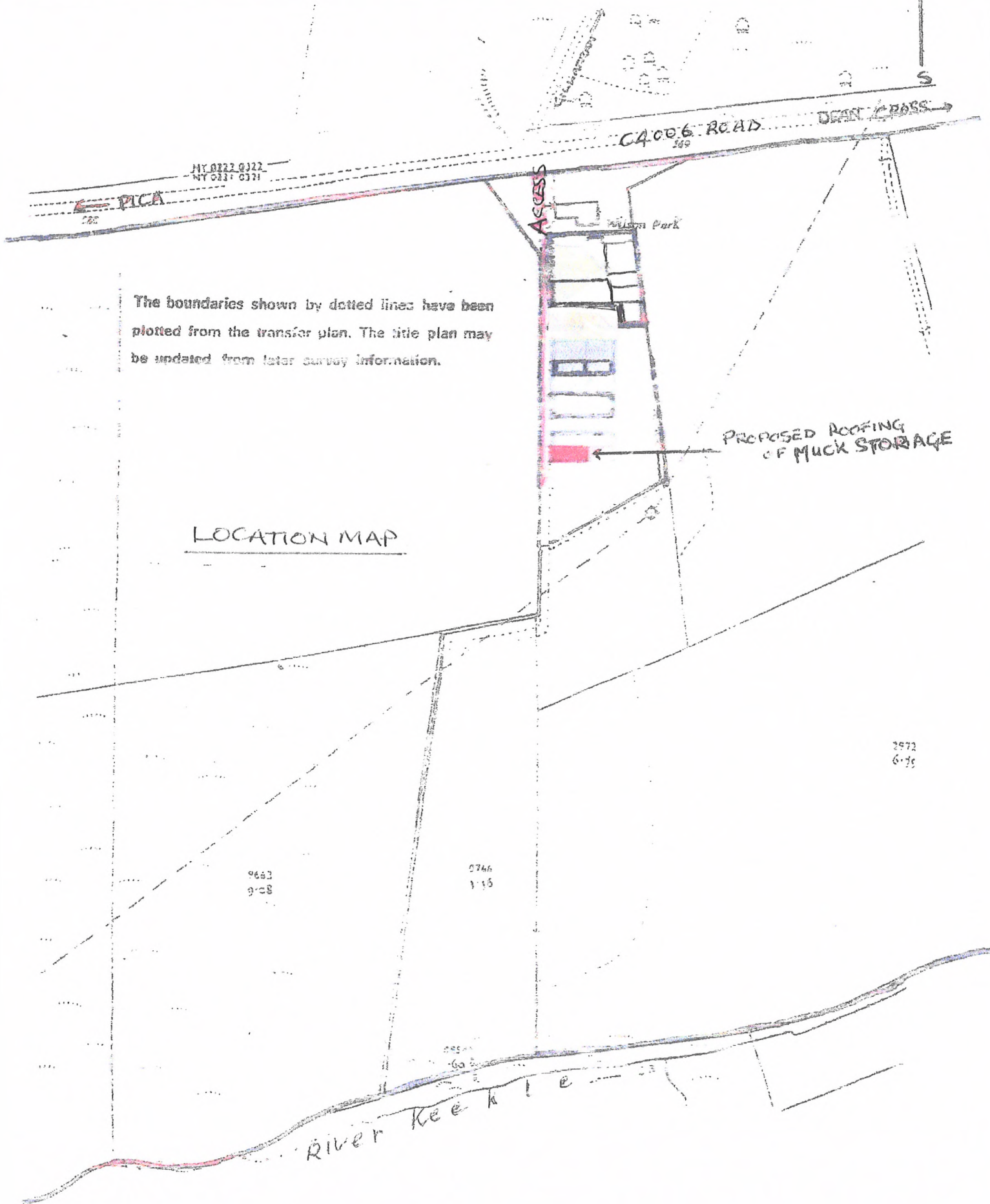
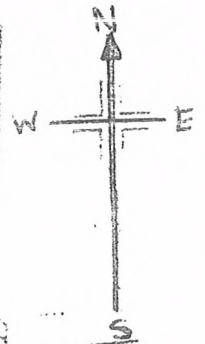

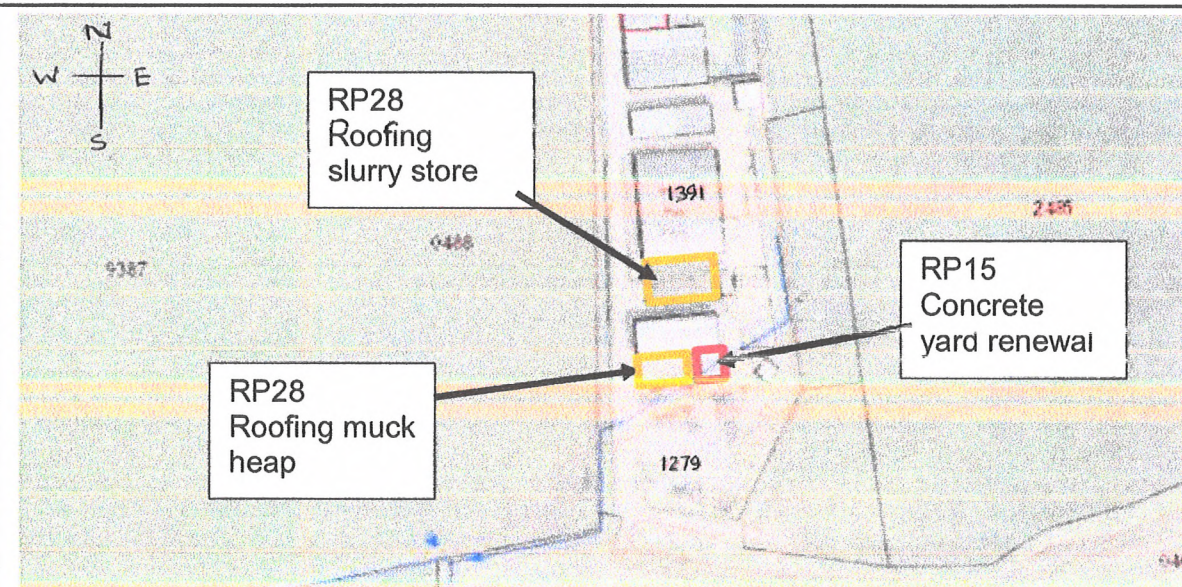
The boundaries shown by dotted lines have been plotted from the transfer plan. The title plan may be updated from later survey information.

Roofing the muck heap and slurry store will ensure rainwater does not soak the muck and slurry, therefore reducing the volume of dirty water containing nutrients, sediment and faecal matter produced which requires storing and spreading. Concrete yard renewal at the entrance to the muck heap will ensure that this area can be kept clean and prevent contamination of surface waters with nutrients, sediment and faecal matter.

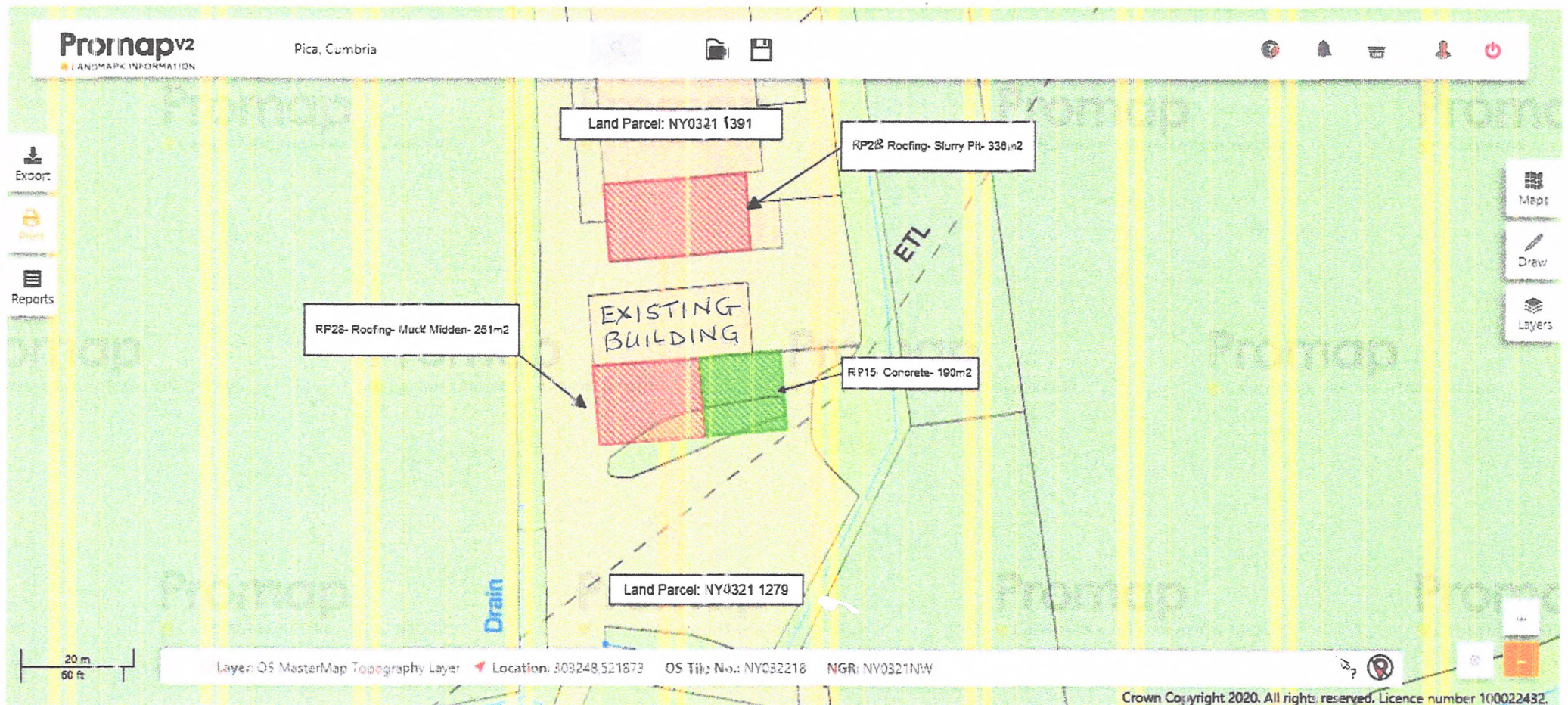

Work to minimise the risk of agricultural runoff reaching groundwater or surface water is good environmental practice and is something that the Environment Agency would recommend wherever appropriate.

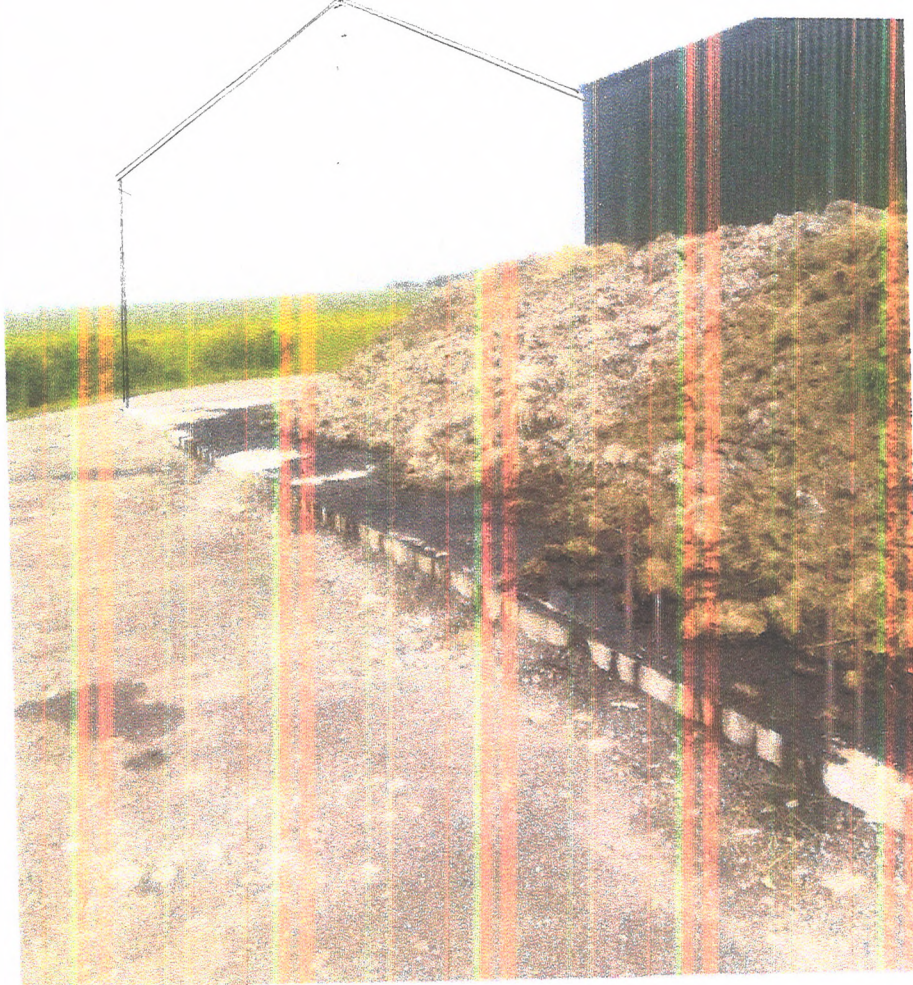

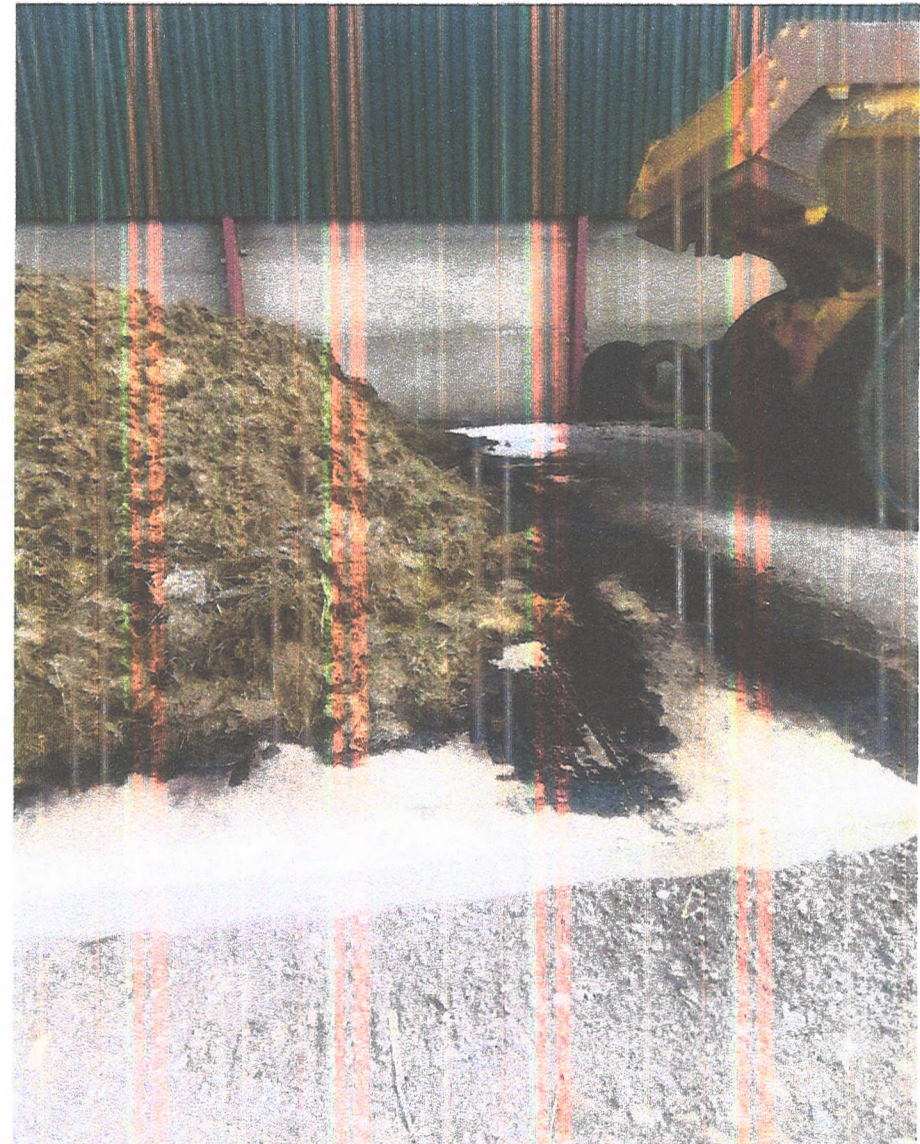
